## EXHIBID EXHIBITION FUND

### GENERAL

1. These Terms and Conditions apply to all contributions granted by Exhibitid (“us”/“we”) to an eligible artist (“you”) from the Exhibition Fund from August 2017.
2. These Terms and Conditions, together with the application form completed and submitted, form the basis of the agreement between Exhibitid and the funded artist, and you need to ensure that you understand these terms.
3. By completing the application form, you are accepting these Terms and Conditions, as well as any additional terms that might be imposed upon the transaction.

### ELIGIBILITY TO APPLY

In order to be eligible to apply for a contribution for your Exhibition, you need to comply with the following conditions. By applying you are confirming that you do comply with all conditions and requirements.

1. You must be 18 years or older;
2. You must have a registered account with Exhibitid;
3. You must have at least 15 (FIFTEEN) active artworks with Exhibitid at the time that the application for funding is granted;
4. You and your artwork must comply with all the terms and conditions of Exhibitid at all times;
5. You must have a valid bank account details loaded onto Exhibitid;
6. The exhibition event to which this application relates must take place in South Africa, and within 3 months of the application being made.

### TERMS OF CONTRIBUTION

1. Applications for a contribution to exhibition shall be made on the designated form and submitted as indicated under <submission details>
2. Contributions are entirely at the discretion of Exhibitid, and no correspondence will be entered into or entertained relating to relative merit.
3. Once an application is considered and approved, no further applications will be approved until the exhibition event in question has been held.
4. The average amount of funding is R1500.00, and past allocations are not binding and must not be viewed as a guarantee of quantum.
5. The criteria for determining the amount of funding, and identity of the grantee, are confidential and not open for discussion with the public. (combine 2)
6. The contribution may only be used for covering actual costs and expenditure related to an exhibition event for artworks by the applicant, and may not be used for any other purpose. The expenses for which it can be allocated are:
  - Venue Rental

- Opening Night Refreshments (including alcohol)
  - Marketing and Advertising
  - Framing costs
  - Labels
  - Hanging supplies
  - Reasonable related expenses
7. Proof of expenditure may be requested, and must be provided.

#### CONDITIONS FOR ACCEPTANCE

Once you are advised of your selection to receive a contribution, you may only accept the monies on the following conditions:

1. The monies paid will be paid into your bank account as loaded on Exhibid;
2. The monies paid may only be used for the purposes requested and specified above;
3. The exhibition must take place at the time and location detailed in the application form, unless reasonable alterations are necessary, of which Exhibid is notified;
4. The exhibit event must display the marketing material as provided by Exhibid for use at the event, and all marketing material for the exhibition must include the logo which will be provided for such use.
5. Exhibid has the right to (a) send a representative to the exhibit, (b) take photographs of the event (c) publicize the event, artist, artwork and funding allocation both before and after the event including electronic images of the event and the artworks displayed and (d) share the event on social media. In order to give effect to this, an invitation must be sent to Exhibid that may be shared by Exhibid in any forum or media
6. Should these terms and conditions not be fully complied with, or the event not take place as scheduled, or the artist refuse to reasonably co-operate with Exhibid in marketing of the event, Exhibid shall have the right to recover any monies disbursed to the artist.
7. The hashtags #exhibid, #exhibidexhibitionfund and #findart are to be used on all social media where the exhibition is promoted or posted by the artist.

#### RELATIONSHIP

1. We are acting as a funder only, and do not take any responsibility for the success or failure of any event.
2. As we exert no influence or control over you, or the event, you are required to indemnify Exhibid and its agents against any claims arising from contractual or delictual liability related to the exhibition event, or any activities by yourself.
3. You must acknowledge the funding grant as publicly as appropriate and practical, following guidelines above. However you may not give the impression that you are directly associated with, or representing, Exhibid.
